PUBLIC PROTECTION CLASSIFICATION

During a recent "Public Protection Classification" survey, ISO completed its analysis of the structural fire suppression delivery system provided in our community with the help of Ricky Spotts, Operator and 2nd Asst Fire Chief from Hickory Corners and Community Fire Company and Craig Gilligan, Fire Chief of the Lower Mahanoy Fire Company. ISO's Public Protection Classification Program plays an important role in the underwriting process at insurance companies. These classification changes have taken effect on 6/1/2016 and should affect the premium you are paying for homeowners insurance at the next renewal. Make sure to check with your insurance agent with any questions when you receive your homeowners renewal and please remember to support your local fire companies who have helped in this endeavor.

POOL FILLING

If a consumer desires to fill or add water (300 gallons or more) to a swimming pool, the consumer must contact the Authority or its operator to obtain the written permission as to the time, date and amount of water which the consumer may use to fill or add to the pool and any restrictions that may be placed upon the water service at that time.

RESURFACING OR CEMENTING

The Authority would like to remind all its customers that if you are planning to resurface your driveway, cement new sidewalks or any other work that would come in contact with your water or wastewater service lines, you must contact our operator at 570-274-0554 at least 48 hours in advance of the work to be performed on your property.

LEAD AND COPPER TESTING

RESPECTING OUR NATURAL RESOURCE

Water is one of our most critical needs for survival that we often take for granted. Climatic changes such as periods of drought have often had negative effects on water supplies worldwide. Although water is a renewable resource, we must be vigilant to use it wisely. Good conservation tips include:

- Repairing leaky faucets and plumbing joints in and around the home. This could save up to 20 gallons per day for every leak stopped.
- Use mulch around tree trunks and plants to slow down evaporation. This could save between 750-1500 gallons a month.
- Water outdoor plants during cooler hours of the day.
- If you have a pool, use a pool cover when not in use. This will not only cut down on evaporation but it will also keep your pool cleaner and reduce the need to add chemicals.

Should a drought situation occur in the remaining months of 2016, restrictions regarding the use of water will be posted in local businesses within the water service area. Again, we thank all citizens who have taken the time to contact our office to report leaks and damages in the water system. Conservation is everyone's job so let's work together to avoid wasteful use of this precious resource.

FYI: COMMON HOUSEHOLD WATER USES

Using Water from a Tap Clothes Washer Dishwasher Shower Bathtub Toilet Low-flow Toilet 1.5 gallons/minute
30-35 gallons/cycle
25 gallons/cycle
2.5 gallons/minute
50 gallons
3.5 gallons/flush
1.6 gallons/flush
