In consideration of being allowed public access to property of the Authority, and intending to be legally bound, the Applicant agrees that hunting, trapping and other recreational activities ("Recreational Activities") are inherently dangerous sports that may involve risk of serious injury, including permanent disability and death, and severe social and economic losses that may be caused by the negligence of the Authority, its, employees, officers or agents, others, accidents, and the forces of nature; such as, exposure to sun, cold, wind, hail, lightning, and other phenomena. Risks and dangers may arise from foreseeable or unforeseeable causes including, but not limited to, falls from treestands, objects which may be encountered, and which may not be obvious, including debris, trees, rocks, holes, stumps, brush and other hazards; feet and other parts of the body may become entrapped in or under rocks and other objects; Applicant may strike or be struck by objects and other persons and all such risks, hazards and dangers are inherent to Recreational Activities that take place in a wilderness, outdoor or recreational environment; and Applicant knowingly agrees to assume the risk of the same and all responsibility for any losses and/or damages, whether caused in whole or in part by the negligence or other conduct of the Authority, its agents, officers, or employees, or by any other person.

On behalf of myself, my personal representatives and my heirs I hereby voluntarily agree to release, waive, discharge, hold harmless, covenant not to sue, defend and indemnify Lower Mahanoy Township Municipal Authority, its agents, officers, and employees from any and all claims, actions or losses for bodily injury, property damage, wrongful death, loss of services or otherwise which may arise out of my use of the Authority's property for Recreational Activities. I specifically understand that I am releasing, discharging and waiving any claims or actions that I may have presently or in the future for the negligent acts or other conduct by the Lower Mahanoy Township Municipal Authority its agents, officers, or employees.
